NOW THEREFORE, it is hereby declared by the Donor founders as Follows:-


1. That the Principal Donor- founder and Donor Founders as the owner of the properties and assets mentioned in the schedule A, B and C annexed hereto convey, transfer and grant unto the Trustees collectively, all and every such properly and assets mentioned in the schedule aforesaid to have and to hold the same in trust for the object of the trust as described below and to be used and appropriated by the trustees in order to carry on and fulfill the said objects in accordance with the directions and wishes of the Principal Donor- founder so far as the same shall extend and the Donor- founders hereby relinguish

The registered office of the trust shall be situated within the Guwahati city. 4. That, the area of operation of the trust will cover seven constituent state of N.E. Region i.e. Assam, Meghalaya, Mizoram, Arunachal Pradesh, Nagaland, Manipur & Tripura. The area of operation may be extended to cover other parts of the country and abroad for some specific purpose. 5. That ,the object of the trust are:to plan, ;promote and organize meaningful, effective and quality education, training, research programme and academic courses related to the filed of Humanities, Arts, Science, commerce, Law, Engineering, Medical Science and other relevant Academic disciplines to design and formulate a comprehensive plan ,programme, and strategy for (ii) implementation of specific schemes envisaged by the trust as per needs and requirements; to established, administer and manage primary, Secondary & Higher Secondary (iii) Schools, and Collages in different parts of N.E. Region of the Country; to run regular and part-time courses at under Graduate, Graduate and post (iv) Graduate levels in the field of Arts , Science , Commerce , Humanities , Education , law and other Academic Disciplines; to arrange and provide basic infrastructure facilities and resources for (v) establishment, operation and Management of academic, Training and Research Institute in the field of Management . Medical Science. Engineering . Computer Science and in other important areas of Vocational & Job-oriented Courses: to hold and conduct lectures; seminars and conferences to evolve a meaningful. (vi) effective and enlightened education Policy and programme suitable to the needs and requirement of the State and the Country; to acquire funds, lands, building and other properties both movable and (vii) immovable and to hold the same for the on behalf of and in the interest of the trust and its objects and to construct, maintain, after or demolish any house, building or works necessary or desirable for the purpose of the trust and its objects: to appoint person or persons for the purpose of representing the trust / the (viii) Management Committee in any legal or other proceedings instituted by or against the trust or the Management Committee either single or in combination of them in a court of law: (ix) to print, publish and distribute gratuitously or otherwise, journals, periodicals, books or leaflets which the trust may consider desirable and necessary for the promotion of its objects; to establish, administer and manage a chain of Secondary & Higher Secondary (x) School, Colleges, Professional Institutions in N.E. states and other parts of the Country and abroad: (xi) to give stipends and scholarships and award diploma and certificates as many be deemed fit: (xii) to prescribe rules and regulations for management, administration and over all control of Schools, Collages, Professional Institutes, Training and research Centers promoted and set-up by the trust;

to appoint attorney or attorneys for any specific or general purpose relating to the (xiii) business and transactions of the trust deemed necessary on behalf of and in the interest of the trust: to do and undertake all such lawful acts and deeds as are necessary and (xiv) conductive to the attainment of the objects of the trust; the management of the trust shall be vested in a Management Committee (XV) constituted under Rule of the trust, which shall consist of the following:-Chairman - One Secretary - One Member - One 6. That, the membership of the trust shall be confined to Principal Donor, Donors and General Members from the field of Academics, Social Works, Literature and Culture. Management committee shall have the power to Co-opt any member to the trust from a specialist field as felt necessary by the committee. Such, co-opted member will render their guidance and advices, when so requested by the management committee. The coopted members will have no voting Rights. 7. That, (i) The management, administration and control of the trust shall be vested in a Management Committee, the member of which shall be nominated by the principal Donor. (ii) The management committee shall consist of one Chairman and two members to be nominated by the Principal donor and out of two members. Principal Donor will be the secretary of the Management Committee. (iii) The term of nominated member of the management committee shall be initially for three years which may be extended to another specified period if felt necessary by the Chairman or the Secretary of the trust. (iv) The principal Donor will be the Secretary of the trust as well as the secretary of the Management Committee. And he will also hold the post of treasurer of the trust and Management Committee. 8. That, 1. The administration and the management and control of the trust shall be vested in the Management Committee which, in addition to the powers and authority expressly conferred upon it by these rules . shall exercise all such powers and do all such things as may be authorised by the Memorandum or exercised or done by the trust and are not by these presents or by any statute required to be done by the trust at its General Meeting of trustees. 2. Without affecting the generality of the foregoing rule, the Management Committee shall have the following general functions and powers: (i) to prepare and execute detailed plans and programmes for the establish--ment of the trust and to carry out its administration and management; (ii) to receive, to have custody and to expend funds of the trust and to manage the properties of the trust; (iii) to prepare and maintain accounts of all financial transactions of the trust and to present and Annual Statement of Accounts and Balance sheet to the Annual General Meeting of the trust, after getting it audited by the

qualified Auditor appointed by the trust from time to time; (iv) to prepare the budget for each year and to sanction expenditure within the limit of the budget; (v) to institute and grant scholarships, stipends, prizes and award diplomas and certificates: (vi) to appoint such staff as may be required for the efficient management of the affairs of the Trust, to control such staff and to regulate their recruitment and conditions of service; (vii) to collaborate and co-operate with other institutions or organizations in the matter of pursuing the object of the trust; (viii) to enter into an agreement for and on behalf of the trust; (ix) to appoint persons for the purpose of representing the trust or the Management Committee in any legal or other proceedings which may be instituted by or against the trust or the Management Committee; (x) to institute, conduct, defend or compound any legal proceedings by or against the trust or the Management Committee; (xi) to appoint Sub- Committees regarding matters pertaining to the trust; (xii)to delegate such powers as may be necessary to the office bearers of the trust including the Chairman and the members working under the trust for administering the trust; (xiii)to perform such additional functions as may from time to time be assigned to it by the trust: That, (i) The chairman shall take the chair at all meetings of the Managements Committee. In his absence the member of the committee authorized by the Chairman shall take the chair and preside over the meeting. 2. The Management Committee shall meet at least once in three months. provided that the Secretary shall call a meeting of the committee at any time upon a written requisition or when so directed by the Chairman . 3. At least fourteen days notice shall ordinarily be given for any meeting, provided that if the Chairman so directs, a meeting, known as an urgent meeting ,may be convenedat such shorter notice as the Chairman may consider sufficient, in case of urgency and as notified by the Chairman. 4. The quorum for a meeting of the Management Committee shall be two members. 5. If a meeting is adjourned for want of quorum, no quorum will be necessary for the adjourned meeting, but such meeting shall be held within 30 days from the date of adjournment. 6.In case of difference of opinion amongst the members at the meeting of the Management Committee on any matter, the decision shall be by majority votes. In each meeting of the Management Committee, each member shall have one vote. The Chairman shall have and exercise a casting vote in the case of equality of votes. 7. Minutes of all the meetings of the Management Committee shall be signed by the Chairman of the meeting at which the minutes are confirmed and by the Secretary. Copies of of minutes of all meetings of the Management Committee shall be sent to all the members irrespective of their attending or otherwise at any particular meeting.

Minutes shall be kept of all general meetings of the trust and shall be signed by the Chairman of the meetings at which the minutes are confirmed and by the Secretary. Copies of minutes of all meetings of the trust shall be sent to all the trustees irrespective of their attendance or otherwise at any particular meeting.

14. That, the audited and certified statement of Accounts and Balance sheet prepared by the Management Committee shall be placed before the Annual General Meeting of the trust for consideration and adoption and such Statement of accounts and Balance Sheet shall be filed with the concern authority within thirty days of holding the Annual General Meeting.

The Annual budget and estimates of expenditure and receipts prepared by the Management Committee shall be placed before the Annual General Meeting of the trust for approval and adoption.

15. That, the trust may frame by laws if necessary to carryout the aims and objects of the trust.

16. That, the trust may amend these rules at any time through a resolution passed at a General Meeting with at least two-thirds of the trustees present and voting in favour of the resolution.

17. That, the Donor- founders have invested the Trustees jointly with themselves with the ownership the possession of the objects matter of the Trust and the Trustees have agreed to accept the Trust.

18. That, the Donor- founders reserve the right to revoke the Trust hereby created at any time during their life time if and when revocation is deemed necessary by the Donor- founders by written notice of the trustees sent by registered post.
